Arts & Crafts Booth Guidelines and Rules

This is an outdoor festival in Paola's historic park square. Please read this information carefully.

REQUIREMENTS:

- With your application you must send in no less than 4 updated photos showing the types and quality of items you will be offering as well as a detailed description of those items. These pictures will be used to place vendors. If you do not send photos your application will be returned. Not necessary for returning vendors unless new products are added.
- The following items will **NOT** be allowed: flea-market items, toy guns, throwing stars, or anything construed to be a weapon, drug-related T-shirts or paraphernalia, fart bags, stink bombs and silly string. The Roots Festival committee reserves the right to disallow the sale of any item(s) it deems inappropriate. A pre-festival inspection after all booths are set up will be conducted and you will be asked to remove any offensive or inappropriate item(s) from the premises. If these items re-appear at any time during the festival you will be asked to leave without a refund, and your application will not be accepted in the future.
- By signing the application you acknowledge that you have read and fully agreed to be bound by the guidelines and rules of this event. Unsigned applications will be returned.

BOOTHS:

- We **WILL NOT** accept booth location requests.
- Booth fees must accompany the application or it will be returned. No faxes accepted.
- We will be placing booths according to the types of merchandise offered, i.e. purely hand-crafted items vs. commercial items vs. community services.
- It is possible that your application for this festival will not be accepted. If we receive a large number of vendors offering the same type of items, if we are unable to identify the quality of your items, or if we receive an incomplete application, your application may not be accepted.
- Booth spaces are open air on grass, or on concrete/asphalt. We do not supply tents, tables, shelving, chairs, etc. Tents must be free standing and fit in the allotted space with adequate weights in case of wind. No vendor will be allowed to stake or drill tents to the concrete/asphalt.
- Electricity is limited. Apply early. Electricity cannot be guaranteed to all that apply. Vendors must supply all extension cords.
- Deadline for applications is Thursday, August 1, 2017. Absolutely no refund if your application is accepted.
- Confirmation letters/calls will be mailed out/called on an "as received/accepted" basis. If your application is not accepted for the festival your pictures and check will be returned to you, along with an explanation.

SET UP:

- Arts and Crafts vendors check-in from 8:00 a.m. until 12:00 p.m., Friday August 25th. **CHECK-IN WILL BE AT THE CORNER OF PEARL AND PEORIA** streets (northeast corner of park square) at which time you will receive your booth packet and space assignment. **Please be patient**, as our volunteers attempt to the best of their ability to expedite placement. **Thursday evening check-in must be pre-approved.**
- Overnight security will not be provided.
- No breakdown of booths before 10:00 p.m. Friday and Saturday night. Any vendors who break down before this time will not be invited to return the following year. **No 'unmanned' booths allowed.**

GENERAL:

- **NO PARKING of ANY support vehicles** on the square throughout the festival with the exception of loading and unloading of wares. Those not complying will be towed at the owner's expense. Parking is available in various parking lots adjacent to park square.
- Paola Roots Fest, Inc. reserves the right to allow/disallow use of generators based on loudness.
- **The Paola Roots Festival must receive application and fees no later than August 1, 2017.** There is a late fee of \$50.00 (due with application) for any submissions after August 1st.
