- Meat Categories – Chicken, Ribs, Pork Butt and Beef Brisket.
- Additional Meat Category – Sausage, additional cost of **\$10**.
- Meat inspections can begin after you have checked in Friday morning.
- A cooks meeting will be held Friday evening.
- Electricity IS NOT available. Use of generators is allowed.
- Water and sinks will be available at designated locations.
- Grease and Ash barrels will be placed at designated locations. You will be responsible to dispose of these in the appropriate barrels.
- All contestants must have at least a 5lb fire extinguisher that has been tagged.
- Turn in times: Sausage 11:30am, Chicken Noon, Pork Ribs 12:30pm, Pork Butt 1pm & Brisket 1:30pm.
